### Introduction to the 2021 Summit

The primary goal of the Summit is to foster the global green bank community of practice and provide tailored assistance to countries who are interested in the green bank model or in the process of developing local green finance institutions. The Summit will also showcase green banks as an implementable solution that help countries and institutions realize their ambitious climate goals and enable green recovery.
